Memorial Day Parade

City Manager Ottenwess explained Parks and Recreation Commission is now planning and organizing the Memorial Day Parade 2019.

Discussed the proposed parade route down Cass Lake Road

Discussed the Parade route change, permits from Waterford and Road Commission of Oakland County for closure of roads for Parade. Team Keego is no longer involved in organizing and funding the parade, but will still provide some financial support. Parks and Rec proposes charging \$25 for profit/political float entries and \$0 for charitable/governmental entries

Fran Leaf park Bid Award

City Manager Ottenwess explained Snider Recreation Inc. was awarded the bid \$20,748.00

The bids were reviewed at the February 13 Parks and Rec Meeting. The style of Playscape was recommended by the Parks and Rec Committee. Some additional funds will be available for this project from CDBG.

Revenue and Expenditure Report

City Manager Ottenwess has been working on items for the 2019/2020 Budget. Ottenwess mentioned capital expenditures, new computers, copy machine, and PD needs patrol cars. Overall the City is on track with the current budget2018/2019.

MDOT Street Administrator

Doug Waldon was the Street Administrator for the City. A resolution is needed to change the MDOT designator Administrator; City Manager Ottenwess will become the Administrator.

Chief of Police Contract

An agreement has been reached with the Chief's contract.

Council Member Lampl noticed that the vacation rollover has no cap, this needs to be addressed. City Manager will address this contract issue.

Considering Fireworks Ordinance Discussion

With the new state law for Fireworks City Manager is inquiring if Council would like to pursue this issue, give City Manager direction.

Council discussion: the 4th of July is the biggest Fireworks Holiday. Tri City Fire will be addressing this issue. Council directed staff to contact Tri City Fire and get their input on this matter.
