Administration Staff Update

Manager Voll indicated a part time employee is needed to work on financial aspects. City Auditor Emmons will assist on quarterly reports not to exceed \$4800.00 a year; she would come to City Council Meetings on her own time. The first and second quarter will need more work than the third and fourth quarter. When in City Hall, City Auditor Emmons will work on the quarterly reports, budget adjustments; but will not handle any day to day transactions.

Mayor Yoder indicated the goals for 2018 – 2019 Budget should include Police Department needs (including vehicle), Police Department contracts and restructuring, City Administration restructuring, reduce unfunded liability, Master Plan, residential parking, capital expense plan. Mayor Pro Tem Fletcher indicated he would like the first \$50,000 from mileage to pay down the unfunded liability.

DPW Spring Update and Discussion

Foreman Waldon indicated he needs another full time person at \$16.00 - \$18.00 and there is definitely enough work for 2 people. Manager Voll stated there are the new properties the City acquired that add to the DPW work load. Foreman Waldon will put together a list of needs to do his job properly.

Recognition Dinner Update

Manager Voll indicated 81 people have responded and will give Mr. Santia final count Friday.

ZBA/Planning Workshop Update

Council Member Kalman will register 10 people for the ZBA/Planning Workshop. 5 Council Members, 3 Planning Commission Board Members and 2 Zoning Board of Appeals Board Members will be attending.
