PUBLIC COMMENT:

Gino Santia – Mr. Santia indicated 1535 Cass Lake Road will be on the Council Agenda for Thursday night. Mr. Santia indicated Planning Commission approved site plan in December. However, the site plan the Planning Commission saw and approved is different than the site plan that the City Council saw. As per the City Council December Meeting, this item was sent back to the Planning Commission. However, Mr. Alonzo will not do that, he is insisting to be on the City Council Agenda. Mayor Yoder indicated by State law an applicant must provide stamped sealed drawings by a licensed engineer. The City Engineer and City Inspector discussed this law with Mr. Alonzo. Mayor Pro Tem Fletcher added any alteration to a commercial building; a stamped sealed drawing must be submitted.

Study Session Topics:

Project proposal for; Cut the Crap, dog waste stations

Kelly Lindberg indicated at the May 9, 2018 Parks and Rec Meeting there was a discussion to purchase 2 dog waste stations. These 11 gallon stations will help to minimize dog waste left on the ground throughout the City. Ms. Lindberg asked for the City to purchase 2 stations and Parks and Rec will be responsible to recruit 6 volunteers to empty them. A dog owner can pick up a bag at one station and leave the filled bag at the other station. The cost of the 2 waste stations, including a 10 month supply of liners and biodegradable bags is \$610. Spots for these waste stations have yet to be decided. Council Members discussed the next step is for Ms. Lindberg and Parks and Rec to decide where the waste stations should be placed. Then this item would possibly go on the 2018 – 2019 Budget.

Walking Path to Fran Leaf Park from Cass Lake Road

Council Members discussed including this path in the price of survey. Planner Jason Smith and the Planning Commission should start working on the research for a Wetlands Ordinance.

Decorative Streetlight discussion

Council Members discussed how to fix on streetlight poles. Mayor Pro Tem Fletcher indicated he is looking for a long term solutions that will not fade. Discussion continued about bases, elimination of bases and color of lights. Manager Voll indicated the TIFA board can put Streetlights on their priority list, can only buy new, can't maintain.

Officially Naming of City Manager

Mayor Pro Tem Fletcher described how Linda Voll, who was City Clerk, has stepped up to take on the role of City Manager and City Treasurer. He added Manager Voll needs to be financially compensated starting July 1, 2018. Council Members discussed their willingness to promote Manager Voll the City Manager. Manager Voll requested a Closed Session for Thursday May 17, 2018. The City needs a person for Economic Development.
