Residential Parking

Planner Smith and Commissioners discussed the potential amendments to the Parking Ordinance Section 4.06. Commissioners discussed removing the 20' maximum restriction in both figure 1 and figure 2. In figure 1, they discussed changing the 8' minimum from house to 3' with landscape buffer. And in figure 2, they discussed allowing the driveway to set right against the road. Also discussed was which improved surfaces would be allowed, it was decided that concrete, asphalt, brick and cut stone are acceptable materials. During the building process, the City should ensure 2 proper inspections to prevent settling and overgrowth. Planner Smith

will bring the amended draft ordinance language to the June 4, 2019 Planning Commission meeting. Once the draft ordinance language is approved by the Planning Commission, the next step will be a public hearing and recommendation for approval by Planning Commission to City Council. One year after adoption, the ordinance will be reviewed by the Planning Commission.
