## Instructions for absent voter ballot applicants

Step 1: Fill out the application completely. You must sign the form to get a ballot.

**Step 2:** Deliver the application in any of these ways:

- 1. Mail it. Make sure the envelope has proper postage and is addressed to your local clerk.
- 2. Deliver it in person to the clerk, the clerk's office, the clerk's authorized assistant or the clerk's drop box.

Someone in your immediate family or living in your household can help you deliver this application. If that's not possible, you can ask any Michigan registered voter to deliver it for you. The person helping you must sign the "Certificate of Authorized Registered Elector Returning Absent Voter Ballot Application" in Section 5 of your application.

 Instead of returning a paper application, you can apply online at <u>Michigan.gov/</u> <u>Vote</u>. Or, you can email a copy of this form. Take a picture of the application (or scan it) and email it to your clerk. Make sure your signature is visible.
