WHEREAS, Traffic Control Order No. 21-01 has been issued by the Traffic Engineer under provisions of the City's Traffic Code, as amended; and

WHEREAS, under the provisions of Ordinance No. 172 of the City of Keego Harbor, the Michigan Vehicle Code and the Uniform Traffic Code for Cities, Townships and Villages the City Council and/or Traffic Engineer are authorized to place and maintain traffic control devices, signs, or signals on any highway under their jurisdiction for the purpose of regulating, warning, or guiding traffic; and

WHEREAS, all of the streets within the City of Keego Harbor fall under the control and direction of the Keego Harbor Police Department; and

WHEREAS, in the interest of public safety, because of the narrowness of City streets, it is deemed necessary to restrict any form of parking on the City streets to insure appropriate emergency vehicle response capabilities;

NOW, THEREFORE, BE IT RESOLVED, that City Council wishes to make permanent the parking restrictions of Traffic Control Order 21-01.

BE IT FURTHER RESOLVED, that any parking on the paved portions of the roadway is prohibited on all public streets within the City of Keego Harbor.

BE IT FUTHERER RESOLVED, that legible signage shall be posted at each roadway entrance to the City of Keego Harbor to serve as notice of the regulation established, and a Traffic Control Order be filed with the City Clerk of the City of Keego Harbor.

BE IT FURTHER RESOLVED, that the City Council approves Traffic Control Order No. 21-27, which shall remain in effect unless or until rescinded or superseded by subsequent order.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution be filed, together with the Traffic Control Order, with the City Clerk of the City of Keego Harbor, Oakland County, Michigan.
