New Business:

Village Plan Update

Mayor Pro Tem Lampl indicated the working committee has the completed their work and approved the 170 ordinance amendments. He felt it was appropriate for the TIFA Board to hear an overview before the presentation at the Planning Commission.

City Planner Jason Smith informed the board Wade Trim is on Phase III on the Village Overlay District. The Village Plan is to make a walkable community with an urban design. He reviewed the overview, showing Village Overlay District Map, Context Zones, how to incorporate the 170 ordinance changes to the district. Planner

Smith described the vision of the Village Plan with zero setbacks, form-based codes, and parking in the rear of businesses.

Financial Report

Planting of Tree in TIFA District

Secretary Clark asked for money to go towards a required match from the DTE Tree Grant.

Crosswalks

Mayor Pro Tem Lampl explained the procedure of applying to Oakland County Road Commission for a lighted crosswalk. The cost of a lighted crosswalk is \$260,000.00.

Old Business:

Capital Improvement Discussion

Board Members discussed the removal of the tree at Sunset Park. The tree is located on the property owned by Sylvan Lake Condos. The City will notice the neighbor and get written permission from Sylvan Lake Condos before the City removes the tree.

Resolution by Vice Chairperson Emerling; seconded by Secretary Clark to approve removal of tree in Sunset Park, not to exceed \$4,000.00

Board Members discussed replacing the fence around the landscaping at Sunset Park. The black metal decorative fence will protect the landscaping from damage.

Resolution by Vice Chairperson Emerling; seconded by Secretary Clark to approve the removal and reinstallation of decorative fence in Sunset Park, not to exceed \$10,000.00 Unanimous Roll Call Vote Ayes: 7 Nays: 0 Motion carried

Board Members discussed fixing all sidewalks in the TIFA District. DPW Foreman Mills or HRC will assess the damage, then the City can go out for quotes.

Board Members discussed hiring a landscape architect to review surface parking lots at the City owned properties on Cass Lake Road and at Webb Park.

Light Pole Bases

The City has received two samples of the base, both had issues. Meetings have occurred with City Staff and Terracast to correct the problems. However, Terracast has not presented a solution to the City. Some board members are concerned with the shipping, installation, and overall manufacturing of the bases. The recently painted light poles and look great, the board discussed keeping the bases as is and looking for resin composite poles in a few years. City Staff will look to replace and / or repair the beauty bands.
