1754 and 1746 Cass Lake Front – Addition to Single-Family Home in NR Neighborhood Residential District, Section 12.02(d) Nonconforming Structures and Section 4.08(4)(a) Side Yard Setback

Open Public Hearing: 6:10pm Close Public Hearing: 6:33pm

Planner Smith reviewed his memo indicating the applicant is requesting to enlarge a non-conforming structure that would create a nonconforming setback on the south side of the property after lot combination of two tax parcels. The applicant is proposing to enlarge the structure at 1754 Cass Lake Front and expand into the vacant lot to the north. Each of the two lots have approximately 40 feet in width and 236 feet in depth thus creating an 80-foot-wide by 236 feet deep lot.

Board Members discussed the following requirements for approval:

- City Council approval of lot combination of the two subject tax parcels (Tax ID #, 18-02-276-007 and 18-02-276-006).
- Submit a site plan and survey to be stamped by a licensed surveyor along with corrected zoning analysis.
- Engineering drawings be reviewed and approved by the building department and engineering department to protect neighboring properties from soil erosion, damage, and drainage patterns.
- Architectural renderings to be submitted and reviewed by the Architectural Review Committee (ARC) in accordance with the City of Keego Harbor Residential Architectural Checklist.
- Ensure that the side yard setback on the north side of the property comply with a 16-foot setback.
- Ensure that the second story does not encroach on the required side yard setback (8 feet on the south and 16 feet on the north).

Resolution by Board Member Shimansky, support by Board Member Svaluto to approve variance request pending completion of requirements stated in staff report and the ZBA agrees with the applicant's statements provided within the ZBA application that the criteria of Section 17.03(c)(B) have been met thus creating a practical difficulty.
